Guest Speaker. Darby DuComb, Chief of Staff, Seattle City Attorney's Office (Peter Holmes had to cancel)

- Darby opened for questions and comments immediately
- Aurora Motels
 - "Italian" & "Isabella" are going out of business and are going through foreclosure process which should finalize in 60 days. The banks will end up with properties, and it's uncertain what will happen after that. Darby iterated through a spectrum of possibilities including low and mid income housing, temporary housing for fisherman & musicians, etc.
 - Recommendation for the community to write a letter to Seattle Housing to outline a vision of what should take the place of motels. Letter can be addressed to Rick Cooper.
 - There are a few investigations pending regarding the remaining motels
 - Important to call 911. 911 calls is what is used to substantiate police staffing plans.
 - Is there a zoning solution -- "up-zoning"? Derby's immediate response is that its' very costly. However, the cost of up-zoning the motel area would be less than half of a police officer on staff.

 - State law that prohibits police from targeting intoxicated individuals
